## CONDITIONS OF PARTICIPATION. PLEASE READ CAREFULLY!

- 1 **Art Expo participants are required to maintain their AGAC membership. Failure to do so will result in having to re-apply to be juried into the show.**
- 2 **AGAC members participating in Art Expo are expected to participate in set up and take down of the show. Those unavailable for personal reasons must find a substitute to take their place for these days. Failure to do so may lead to cancellation of membership and participation in the show.** *(Not all tasks are physical. Please see sign-up sheet at the September meeting)*
- 3 Members exhibiting in the previous year who wish to occupy the same space for the next Art Expo will be accommodated, if possible based on floor plan.
- 4 Booths larger than 32 lineal feet may be accommodated if circumstances permit, based on floor plan. Additional 4 ft panels are available at \$100 per panel.
- 5 Existing members who did not exhibit the previous year will receive priority, provided they have maintained their membership. Followed by new members on a first come-first served basis.
- 6 The work of all new applicants will be subject to a jury selection process. The decision of the jury is final and will not be subject to discussion.
- 7 All work exhibited must be of the artist's own creation and composition. Works copied in whole or in part from published material by other artists will not be permitted.
- 8 Only the work of the artist whose name is on the booth may be displayed in that booth.
- 9 In order to ensure uniformity, extraneous decorating of booths is not permitted. The covering of panels or tables is limited to **black or white fabric only**. All accessories on the table must be either black, white or clear plastic. **Lighting is mandatory and must be uniform** in either black, white or aluminum in colour. **There will be no exceptions to this.**
- 10 The Cooperative is not responsible for loss, damage or theft of artists property.
- 11 The artist is responsible for following all directions regarding sales at Art Expo.
- 12 Any decision by your Board of Directors shall be final and binding.
